The Humane Society of North Central Florida offers all pet parents an opportunity to eliminate the emotional distress, financial obligation and lifestyle changes that contribute to the abandonment of animals after an illness or death.

Many make extensive plans to ensure the future of their loved ones to provide for the needs of those that we leave behind when tragedy or illness strikes. Sadly, we often fail to make the same plans for our pets who may then be surrendered to local shelters.

What is the Happy Tails Program?

The Happy Tails program allows pet parents to guarantee the adoption of their pets if they are unable to care for them due to injury, illness or death.

How does it work?

Any pet owner can enroll their pets in our Happy Tails program. After enrollment, if injury, illness or death were to occur and you are no longer able to care for your pet, HSNCF will take your furry companion in until a suitable, permanent home is found. Our unique adoption questionnaire allows you to describe, in detail, how your pet has been cared for, what their favorite toys are, what type of games or treats they like best or any other personal information you'd like a potential adopter to know. Due to facility limitations, HSNCF can only guarantee the acceptance of dogs and cats. Happy Tails ensures your pets' needs are met and their future is bright!

How much does enrollment cost?

There are several different options for enrollment, which include:
Pre-Payment: Pet owners complete the Happy Tails application materials and create an adoption file for the specific pet. The donation required is \$1,500 for each cat and \$2,000 for each dog.

Deferred Payment: Pet owners who have life insurance, but who would like to defer payment, can set up their estate to distribute funds upon their passing. The pet owner must have an attorney handling the distribution. The donation required is \$2,000 for cats and \$2,500 for dogs.

Humane Society of North Central Florida is recognized under the IRS as exempt under section 501c3 and is registered with the Florida Division of Consumer Services, license number CH715.

Donations are tax deductible to the full extent of the law.
