IN 2015, ALACHUA COUNTY HUMANE SOCIETY (ACHS) ACCEPTED 1,020 DOGS AND CATS (AND TWO FERRETS) INTO THE ORGANIZATION'S ADOPTION PROGRAM. THESE ANIMALS WERE PROVIDED SHELTER, DAILY CARE, AND MEDICAL TREATMENT WHILE WAITING TO BE PLACED INTO PERMANENT HOMES. OF THESE 1,020 DOGS AND CATS, APPROXIMATELY 43% WERE AT RISK OF EUTHANASIA AT ALACHUA COUNTY ANIMAL SERVICES (ACAS). AN ADDITIONAL 20% WERE TRANSFERRED IN FROM OUT OF COUNTY MUNICIPAL SHELTERS OR RESCUE PARTNERS. APPROXIMATELY 25% WERE STRAY, UNDERAGE ANIMALS AND THE REMAINING 12% WERE SURRENDERED BY THE PUBLIC.
